### *Minutes*

#### 1. Call to Order and Roll Call

The meeting was called to order at 4:47 pm by Co-Chair Jewell. Roll was called and quorum was established.

#### 2. Review/Approve March 28<sup>th</sup> 2011 DRAFT Agenda – VOTE

The March 28<sup>th</sup> 2011 DRAFT agenda was reviewed and approved by consensus.

#### 3. Review/Approve February 28<sup>th</sup> 2011 DRAFT Minutes – VOTE

The February 28<sup>th</sup> 2011 DRAFT minutes was reviewed and approved by consensus.

#### 4. Announcements

- CS Molnar announced that the Transgender Women’s Needs Assessment Workgroup met last week. It is an ongoing and open process and all Council Members are invited to come.
- CS Molnar also announced that all FPPC 700 forms will be due by the end of the month.
- CS Lee has announced that the Planning Council has been nominated to be one of the grand Marshalls for the Pride Parade.

#### 5. Public Comment

- Michael Smithwick, executive director of Maitri, spoke about the resource allocation process and said that he hopes that the Planning Council will continue to sustain support services.

#### 6. HIV Health Services Report

Bill Blum, from DPH-HHS, gave the following update:

- 6) Training
  - a) HHS training for providers on long term disability benefits, health care reform and financial planning for HIV and Aging population is currently under planning

#### **7. PLWH Updates**

CM Jewell updated the Council on the status of the PLWH Caucus. The Steering Committee had a robust discussion and offered suggestions. The Caucus will be meeting to come up with a mission statement and will report back to the Council once that is developed. If Council members are interested in attending, more information is to follow.

#### **8. At-Large Steering Committee Member Elections – VOTE**

The Council considered and voted on the following Council members for At-Large Steering Committee membership: CMs Matillano and Simmons.

The Council voted CMs Matillano and Simmons as At-Large Steering Members by consensus.

#### **9. Membership Items – VOTE**

The Council reviewed motions from the Membership Committee (3/14/2011) and voted on renewing the following Council members: CMs Chandler, Pillatzke and Miller.

The Council approved the Council Members' membership renewal by consensus.

## 10. HIV Update Presentation

Henry Fisher Raymond of DPH Epi section presented the Council with an update on the HIV epidemic in San Francisco. An excerpt of the presentation:

- Total
  - 815,358 population size (~2.4% rise since 2006)
  - 18,576 living with HIV (prevalence 2.27%)
  - 736 new infections (incidence rate 0.09%)
    - 30.8% reduction in rate
    - 24.6% reduction in number
- Plausibility Bounds for New Infections 2011
  - 534 Lower Plausible
  - 977 Upper Plausible
- MSM (non-IDU)
  - 59,809 population size
  - 13,565 living with HIV (prevalence 22.7%)
  - 585 new infections (incidence rate 1.27%)
- MSM-IDU
  - 4,874 population size
  - 2,308 living with HIV (prevalence 47.4%)
  - 49 new infections (incidence rate 1.92%)
- Transgender (MTF non-IDU)
  - 1,064 population size
  - 377 living with HIV (prevalence 35.5%)
  - 17 new infections (incidence rate 2.48%)
- MSF-IDU
  - 7,884 population size
  - 986 living with HIV (prevalence 12.5%)
  - 20 new infections (incidence rate 0.29%)
- MTF-IDU
  - 464 population size
  - 206 living with HIV (prevalence 44.4%)
  - 15 new infections (incidence rate 5.7%)
- FSM/F-IDU
  - 5,772 population size

- 599 living with HIV (prevalence 10.5%)
- 14 new infections (incidence rate 0.27%)
  
- FSM/F
  - 3,626 population size at risk\* (335,586 adult F non-IDU)
  - 289 living with HIV (prevalence 8.0% of at risk or 0.086% of total pop)
  - 17 new infections (incidence rate 0.51% of at risk or 0.0051 %)
  
- MSF
  - 2,991 population size at risk\* (281,976 adult M non-IDU, non-MSM)
  - 138 living with HIV (prevalence 4.6% of at risk or 0.049% of total pop)
  - 18 new infections (incidence rate 0.63% or 0.0064% of total pop)
  
- Persons Infected Peri-natally
  - 28 persons living with HIV infected as infants
  - 0 new infections among infants
  
- Blood
  - 29 persons living with HIV infected via blood product exposure
  - 0 expected new infections (risk < 1 in 3 million)
  - Those individuals whose risk is having sexual risk with a high risk partner (MSM, IDU, Transwoman)

#### **12. ECHPP Update – VOTE**

Tracey Packer and Dean Goodwin of DPH presented the Council with an update on the Enhanced Comprehensive HIV Prevention Planning and Implementation (ECHPP). The presentation offers the CDC language as well as the “San Francisco” translation, as well as the potential impact for HHS providers and/or clients. An excerpt of the presentation:

- The ECHPP process is one way that the federal government is implementing the National HIV/AIDS Strategy
- The ECHPP Plan is a description and justification of the SF HIV/AIDS Strategy
  - It outlines how all sections of the health department will address HIV/AIDS, with a focus on prevention
- The ECHPP grant specified that it should be a health department planning process and that community planning group feedback should be included
- The ECHPP Plan reflects:

- The services described in the HIV Prevention Section and Centers of Excellence RFPs as well as DPH-delivered services
- A scale up of HIV testing and interventions for HIV-positive people
- A scale down and re-focusing of interventions to reduce sexual risk behavior

The 14 recommendations:

1. Routine, opt-out screening for HIV in clinical settings of patients ages 13-64
2. HIV testing in non-clinical settings to identify undiagnosed HIV infection
3. Condom distribution prioritized to target HIV-positive persons and persons at highest risk of acquiring HIV infection
4. Provision of post-exposure prophylaxis (PEP) to populations at greatest risk
5. Efforts to change existing structure, policies and regulations that are barriers to creating an environment for optimal HIV prevention, care and treatment
6. Linkage to care, treatment and prevention services for those testing positive and not currently in care
7. Interventions of strategies promoting retention in or re-engagement in care
8. Policies and procedures that will lead to the provision of antiretroviral treatment in accordance with current treatment guidelines
9. Interventions or strategies promoting adherence to antiretroviral medications
10. STD screening for HIV-positive people according to current guidelines
11. Prevention of perinatal transmission
12. Ongoing partner services
13. Behavioral risk screening followed by risk reduction interventions for HIV-positive persons (including those for HIV-discordant couples) at risk for transmitting HIV
14. Linkage to other medical and social services for HIV-positive people
